QMS™ Version 4.0 is here!

You will be receiving the new QMS™ Version 4.0 in the next few days. The following is a list of enhancements you will see in Version 4.0:

Quality/Risk

- Default footer for all reports in the Quality/Risk module
- Link transactions to scanned documents, images, spreadsheets, etc.

eQMS™

- Enter multiple indicators in eQMS™ (our online event reporting tool)
- New field for the Person Entering the event
- Ability to specify certain fields as either required or not required (Birth Date, Who Entered Event, Event Time, and Report Date)
- Enable or disable the Patient Lookup
- Enable Patient lookup by Control Numbers only
- HL7 Interface patient lookup

Credentialing

- New fields have been added in Credentialing to allow our clients to keep track of important information such as: NPI Number, Email Address, Mobile Phone, End Date, and Sponsoring PX.
- New Practitioner Statuses have been added: Affiliate, FPPE, OPPE, Emeritus, Fellow, LOA, Locum, and Inactive.
- Link practitioners to scanned documents, images, spreadsheets, etc.
- Ability to filter by Practitioner Status when running reports (Inactive vs. Active, etc.)
- Increased character length for BCBS, Medicare, and Medicaid fields.
- Notes were added to Continuing Education and Affiliation tabs.

Claims

- New claims status choice of "Potential" in addition to Open and Closed
- Link claims to scanned documents, images, spreadsheets, etc.

Data Transfer

- Ability to change Patient Name, MR#, and Control # in the event holding pen before importing events to Quality/Risk.

Did You Know??

- Quality/Risk can be used to track Peer Review, Complaints/Compliments, and HAC's.
- Activities can be set up for specific indicators that will allow you to run rate reports so that you can see what percentage of falls, medication errors, etc. you have by month.
- Expiration Dates can be created for OPPE and FPPE in Credentialing so that you can keep track of when these specific physician evaluations are due.
- eQMS™ enables staff to enter reportable events real time through a web browser.
- eQMS™ can be configured to send automatic email alerts when events are submitted.
